### **Bylaws**

Bylaw No. 14-729 for NW 18-69-21-W5M passed first reading. The lands are to be re-designated from Agricultural District to Recreation District. A public hearing for the bylaw will be held on October 14, 2014 at 10:00 am in Council Chambers.

### **Sale of Surplus Equipment**

Council approved sale of a number of items at the October 1, 2014 Richie Brothers Auction.

### **Rail Rock Gravel Haul Contract Funding**

Additional funding will be provided to offset costs of relocation of existing gravel reserves to a newly developed stockpile site at kilometer 70 on the Forestry Trunk Road. The relocation will allow space for additional gravel crushing required in fall 2014 and enable more efficient maintenance of the Forestry Trunk Road.

### **Crooked Creek Arena Boundaries**

A boundary report was provided as information to Council regarding the Crooked Creek arena. The report will assist the Crooked Creek community as they plan possible expansion of their parking lot and investigate future upgrades.

### **Grants**

- Crooked Creek Community Recreation Club \$34,249.34 for capital and operational expenditures.
- DeBolt High School Rodeo Association \$1,600.00 for the Seventh Annual DeBolt High School Rodeo to be held at the Cranberry Lake Rodeo Grounds in DeBolt on September 13 and 14, 2014.
- Valleyview Victim's Assistance in the amount of \$500 for their Charity Event September 27, 2014 at the Memorial Hall.

### **Little Smoky Ski Hill Agreement**

Council approved a 5 year agreement with the Municipal District of Smoky River No. 130 regarding operating costs of the ski hill. Greenview will provide one third of the annual net operating costs of the Little Smoky Ski Area to a maximum of \$65,000.00 per year. In addition, Greenview will provide up to 20% of the operating deficit of the facility to a maximum of \$10,000 per year.
