Application Deadline is April 15, 2019

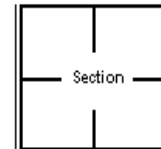
The Dust Control Program has been established by Council for residential and industrial projects and a Calcium Chloride product will again be used as the dust control resource. Rates for residential users are as follows:

- *Option 1:** \$150.00 for the first 200 m, plus \$5.35 per lineal metre for any distance over 200 m.
- *Option 2:** \$100.00 for 100 m (*for multi-parcel subdivisions only*)

Please note there is no G.S.T on Residential Dust Control Application Fees.
