#### BACKGROUND/PROPOSAL:

The Grande Cache Animal Society is a local registered non-profit society that is active in the community rescuing and advocating for abandoned, neglected, abused and surrendered animals in the Grande Cache area.

For several years the society has functioned to give assistance to stray animals at large and assist in animal population control by spaying/neutering all animals that are rescued and provide an option for the surrendered animals. Rescued animals are re-homed to best suited applicants or to other animal shelters in an effort to give the best chance to all animals to find their forever homes.

All Society funding is gained through donations and fund raising. In the last year, the society has rescued over **sixty** animals and have done this through animal foster care alone with no facility.

The society sees many animals left abandoned or mistreated from the surrounding area, not just from within the Town of Grande Cache limits. Recently, the Town of Grande Cache requested that the group no longer utilize the old existing pound location as a facility for storage. The organization has since acquired a new storage area for belongings and donations, however this has added to the overall financial burden of their operations.

Currently the society is fundraising to not only continue to fund operations but also to work toward having a facility to operate out of to house the animals while they are in the transition stage. The society is seeking grant funding from Greenview to continue to operate and secure funds for an animal facility, however no specified amounts has been provided at this time.

The Grande Cache Animal Society was provided a \$10,000.00 operating grant in 2018. Community Services Miscellaneous Grant currently has a balance of \$62,471.57 as of June 8, 2018.

#### BACKGROUND/PROPOSAL:

The Willmore Wilderness Foundation (Willmore) is a registered charitable organization with a focus on pack trail maintenance, film production for tourism and marketing, historical research and education. The area of focus of these activities occurs in the Improvement District No. 25 (Willmore Wilderness Park) located adjacent to Grande Cache and Greenview, with some of their activities crossing over into Greenview.

Greenview has supported Willmore since 2006 in the form of providing letters and has provided \$490,500 of financial support since 2011. The most recent partnership agreement between the organizations took place in February 2018 in which Greenview provided a \$107,000 contribution to be used for Willmore's operations and photographic and video materials. In addition to this, Willmore is identified in the Greenview Recreation and Tourism Partnerships section of the approved 2018 budget for financial support from Greenview in the amount of \$100,000 in 2019 and 2020.

In addition to the existing partnership, it is the desire of Willmore to enter into a Memorandum of Understanding (MOU) with Greenview. This agreement does not indicate a specific financial amount, but formally recognizes that Greenview will collaborate with them on tourism and internet marketing campaigns, contract Willmore for delivery of services within Greenview south of Kakwa River, provide infrastructure improvement funding for Willmore Wilderness Park and assist with improvements. In addition, Willmore would like Greenview to formally recognize their expertise in GIS mapping, and knowledge of Willmore Wilderness Park and Greenview south of the Kakwa River.

The purpose of this presentation is for Willmore to provide Council with information on this proposed partnership. However, Administration believes that the current partnership arrangement with Willmore is

sufficiently secured and adequate for Greenview's needs. In addition, Administration has recently spent time and effort developing numerous relationships with Provincial Ministries, Industry Specialists and Tourism experts in anticipation of developing future tourism opportunities within the Grande Cache area. Future development may include attraction based offerings, motor-vehicle or real-estate development opportunities.

#### **DRAFT Memorandum of Understanding**

between

Willmore Wilderness Preservation and Historical Foundation aka Willmore Wilderness Foundation and the Municipal District of Greenview #16 formalizing a partnership between the MD of Greenview / Willmore Wilderness Foundation

#### It is understood that:

 The Willmore Wilderness Foundation is the steward of Improvement District No. 25 (Willmore Wilderness Park). The Willmore Wilderness Foundation manages and implements infrastructure improvements, public education, training, tourism promotion, marketing and historic research to preserve the history in Improvement District No. 25 (Willmore Wilderness Park.)

Improvement District No. 25 (Willmore Wilderness Park) is 4,600 square kilometers (1840 sq. mi.) and its southern boundary is the world-famous Jasper National Park. Other parks surround this wilderness reserve including Kakwa Wildlands Park to the north, and British Columbia's Kakwa Provincial Park to the west. Municipal District of Greenview No 16 lies to the north.

- 2. The Willmore Wilderness Foundation will be treated as a neighbouring partner of the MD of Greenview.
- 3. Municipal District of Greenview would contract the services of the Willmore Wilderness Foundation in the delivery of services to the MD of Greenview No. 16, south of the Kakwa River.
- 4. The MD of Greenview will provide core Operational Funding to the Willmore Wilderness Foundation.
- 5. The MD of Greenview will provide infrastructure improvement funding for Improvement District No. 25 (Willmore Wilderness Park). This will be focused on cross jurisdictional boundaries between the two regions.
- 6. The Municipal District of **Greenview** No. 16 recognizes that the Willmore Wilderness Foundation has professional expertise in the following areas.
  - The Willmore Wilderness Foundation professional staff are:
    - extremely knowledgeable of Improvement District #25
    - have an intimate knowledge of the Municipal District of Greenview No. 16 land base, from the Kakwa River south.
    - This includes a deep understanding of the recreational opportunities, historical

sites and stories of both jurisdictions.

- The Willmore Wilderness Foundation professional staff has expertise in ArcGIS. ArcGIS is a geographic information system (GIS) for working with maps and geographic information. It is used for creating and using maps, compiling geographic data, analyzing mapped information, sharing and discovering geographic information, using maps and geographic information in a range of applications, and managing geographic information in a database. This information will be beneficial to the MD of Greenview No 16 as well as Improvement District No 25 (Willmore Wilderness Park).
- The Willmore Wilderness Foundation operates Alberta Rockies Adventures, which provides a gateway to breathtaking adventures and activities along the eastern slopes of the beautiful Canadian Rocky Mountains. The program markets folklore, local legends, historic culture, packhorse trips, bed & breakfasts, back-country ranches and lodges to high-value clientele. Hosts are all located on the Eastern Slopes of the Rockies and most offer stunning back-country trips in and around Willmore Wilderness Park, a pristine and untouched area ideal for visitors who wish to partake in the traditional mountain lifestyle.
- Alberta Rockies Adventures has expertise in high-value international clientele tourism marketing and promotion.
- The Willmore Wilderness Foundation owns and operates People & Peaks Productions Ltd. It is recognized that People & Peaks Productions Ltd has expertise in television productions, which have been broadcast on international networks.
- The Willmore Wilderness Foundation and People & Peaks Productions have high level proficiencies in multimedia, social media and transmedia.
- The Willmore Wilderness Foundation and People & Peaks Productions have high profiles with social capital that can be traded as equity. The Willmore Wilderness's social media capital can help kick start other regional internet marketing campaigns.
- 7. MD of Greenview No 16 and Improvement District No 25 (Willmore Wilderness Park) and the Willmore Wilderness Foundation will not work in silos but in a collaborative effort to improve services for residents of this region. This partnership will include the following:
  - Collaborative infrastructure improvement initiative such as interjurisdictional trails upgrades, blazing trails, signage, bridging, campground improvements,

garbage collection, and GPSing trails.

- Collaborative marketing and tourism initiatives for the Alberta Rockies region of the MD of Greenview, and the neighboring jurisdiction Improvement District No 25 (Willmore Wilderness Park). There will be a collaborative tourism marketing strategy featuring Alberta's eastern slopes to Albertans, Canadians and International visitors.

#### BACKGROUND/PROPOSAL:

Administration has been exploring water concerns within the Grande Cache Coops and Enterprises. It was determined through surveys conducted that most of the residents do have water supplied by wells, but that the quality of the water is very poor for the most part and is not suitable for drinking purposes.

The financial costs associated with ensuring the private residential wells are producing safe drinking water is beyond the capabilities of the residents or the municipality. Although there are potable water services available in the Town of Grande Cache, social economic factors of this situation makes it difficult for the residents to access these services.

In the survey conducted, it was indicated by residents that a bottled water delivery program would be favoured. Alternative methods of water delivery were explored and the most economical and sustainable is believed to be the hiring of a local bottled water company. Administration considered the purchase of a delivery vehicle and employ a driver to deliver the bottled water, but it was ruled out as it was a considerable investment that wasn't necessary. Administration also considered hauling water to the residents but only a small percentage of residents have storage capabilities.

Local companies that offered water delivery services in Grande Cache were encouraged to send in a proposal for this contract. The quote submitted by Pür Premium Spring Water Company was the most appropriate proposal in addressing the customer's needs. The fees for the proposed service is \$7.00 per water bottle with an initial deposit of \$12.00 per bottle (fully refundable), plus a \$50.00 north delivery fee and \$50.00 south delivery fee.

Residents would be charged the actual cost of the water, \$7.00 plus \$12.00 deposit, with Greenview subsidizing the delivery fees. This fee quote is provided with the understanding that Pür Premium Spring Water will provide a bottled water and exchange program on a weekly basis (100 bottles per week) to the communities.

Administration will be seeking Council's approval to transfer \$20,000.00 from the 2018 Grande Cache Bottled Water Program Capital Budget to the Environmental Services Operational Budget to cover the costs for the remainder of the year.



### Introduction

The 2017 Planning and Development Year End Report provides an overview of the development activity of the Planning and Development department.

The Planning and Development department is responsible for land use amendments (rezoning), subdivisions, business licensing, rural addressing, referral notifications and development permits, annual renewals for work camps and business licenses. The department must continually update various planning documents that include the Municipal Development Plan, Land Use Bylaw and Area Structure Plans to ensure they continue to remain relevant with current provincial regulations and guidelines and encourage future growth and development.

The Planning and Development department provides recommendations to Council, provides subdivision applications and development permits for discretionary uses to Municipal Planning Commission and attends Subdivision and Development Appeal Board (SDAB) meetings. Greenview's planning processes are guided by the Land Use Bylaw (LUB) and policies which are governed by the Municipal Government Act (MGA).

2017 was a busy year for the Planning and Development department. Open Houses were held throughout the municipality to receive public input, ideas and feedback from ratepayers on important projects such as the Land Use Bylaw (LUB) and the Grovedale Area Structure Plan (GASP).

Planning documents and forms were also modified and improved in 2017, including the Development Guidelines and Municipal Servicing Standards and development permit applications for titled and Crown land.

Greenview is divided into eight (8) wards. There are three (3) development officers that work together as a team but are also assigned to specific wards within Greenview:

- ❖ Lindsey Lemieux: Ward 1 Grande Cache and Ward 8 Grovedale
- Price Leurebourg: Ward 2 Little Smoky, Ward 3 Valleyview and Ward 4 Sunset House/Sweathouse
- Leona Dixon: Ward 5 New Fish Creek, Ward 6 DeBolt/Puskwaskau and Ward 7 Crooked Creek.

The development officers are always willing to assist ratepayers and answer any questions or concerns related to planning and development.

### LAND USE AMENDMENTS

When submitting a land use amendment application, you request to change the current land use designation to enable subdivision or development to take place. In 2017, the Planning and Development department received six (6) land use amendment applications compared to seven (7) received in 2016.

Figure 1 illustrates the types of land use amendment requests that were received in 2017.

Three applications were received to rezone to Country Residential One (CR-1) District, two were received to rezone to Industrial (I) District and one (1) was received to rezone to Recreational (R) District.





Figure 2 shows land use amendment applications received by ward. Ward 6 – DeBolt/Puskwaskau and Ward 8 – Grovedale both received two (2) land use amendment applications. Ward 2 – Little Smoky and Ward 7 – Crooked Creek both received one (1) application.



# **SUBDIVISIONS**

A subdivision divides a single parcel of land into two (2) or more parcels in order to obtain separate legal titles for each parcel. The Planning and Development department received twenty-two (22) subdivision applications in 2017 compared to twenty-six (26) in 2016.

As shown in Figure 3, the subdivisions types that were received in 2017 were: Eighteen (18) first parcel out, one (1) country residential one, one (1) physical severance, one (1) consolidation and one (1) public utility.






Figure 4 shows subdivision applications received by ward. Ward 3 – Valleyview had the most subdivision applications received in 2017.



## **BUSINESS LICENSES**

In 2017, the Planning and Development department received sixteen (16) new Business License applications, compared to twenty-three (23) in 2016.

Greenview approved various types of businesses in **2017** such as: trucking businesses, auto sales, furniture making, automotive repair, farm equipment repair, heavy equipment repair, agricultural businesses, road maintenance contracting, catering, general stores and pet care facility.




# REFERRAL NOTIFICATIONS

Referral notifications are received from Alberta Environment and Parks (AEP) when an individual or company applies for a lease on Crown land within Greenview. A written response is sent back to AEP and to the applicant with comments or concerns. As well, the applicant is informed whether a development permit application is required.

In 2017, the Planning and Development department received fifty-two (52) referral notifications compared to forty (40) in 2016.

## **DEVELOPMENT PERMITS**

A development permit application is required to ensure development adheres to the requirements of Greenview's Land Use Bylaw (LUB). The Land Use Bylaw (LUB) regulates and controls the use and development of the land.

In 2017, the Planning and Development department received 318 development permit applications with a total estimated project cost of \$819,522,678.50 compared to 301 development permit applications with a total estimated project cost of \$521,296,448.00 in 2016.

There are four (4) different categories for the type of development associated with the land: residential, industrial, institutional and commercial. Figure 7 shows the percentage of development permit applications received in each category. Of the various types of development in 2017, 58% was in Crown land, 38% was residential, 2% was institutional and 2% was commercial development.






Figure 8 shows a breakdown of development permit applications received by month in 2017. The month of May had the highest activity for development permits with a total of forty-eight (48) applications.


