



BYLAW 26-1024 of the Municipal District of Greenview No. 16

**A Bylaw of the Municipal District of Greenview No. 16, in the Province of Alberta
to provide for the establishment of the Grande Cache All-Season Resort Advisory
Committee.**

WHEREAS, the Municipal Government Act, RSA 2000, c. M-26, authorizes Council to pass bylaws relating to the establishment and function of Council Committees and other bodies;

AND WHEREAS, Council deems it prudent to establish a Grande Cache All-Season Resort Advisory Committee to advise Council on all matters pertaining to the attraction and development of an all-season resort in Grande Cache;

NOW, THEREFORE, the Council of the Municipal District of Greenview No. 16, in the Province of Alberta, duly assembled, enacts as follows:

1. TITLE

- 1.1. This Bylaw shall be cited as the “Grande Cache All-Season Resort Advisory Committee.”

2. DEFINITIONS

- 2.1. **Act** means the All-Season Resort Act, SA 2024, c A-38.5, as amended from time to time.
- 2.2. **All-Season Resort** means a resort facility located in whole or in part within an all-season resort area where accommodation, activities, services or amenities are provided to members of the public throughout the year and includes any buildings or permanent structures and the infrastructure required to support the resort facility and its operations.
- 2.3. **Committee** means the Grande Cache All-Season Resort Advisory Committee established by Council.
- 2.4. **Council** means the duly elected municipal Council of the Municipal District of Greenview No. 16.
- 2.5. **Greenview** means the Municipal District of Greenview No. 16.
- 2.6. **Local** means residing within or around the Hamlet of Grande Cache.
- 2.7. **Tourism** means travel undertaken for recreational, cultural, or leisure purposes in the Grande Cache area, including the activities, accommodations, services, and experiences that attract and support visitors to the region.

2.8. **Tourism Operators** means a person or organization that provides guided, recreational, educational, or experiential services to participants on a commercial basis, whether offered seasonally or year-round.

3. PURPOSE

3.1. The Grande Cache All-Season Resort Advisory Committee is hereby established to act in an advisory capacity to Council on all matters pertaining to the attraction and development of an All-Season Resort in Grande Cache.

3.2. The purpose of the Committee is to ensure that the pursuit of an All-Season Resort appropriately serves the existing and future community of Grande Cache by providing Council with well-rounded recommendations grounded in local knowledge. The Committee will draw on the perspectives of residents, business owners, and tourism operators to advise on how a resort can best be attracted, how it fits within the community, and how long-term sustainability can be achieved.

4. MEMBERSHIP, QUORUM AND TERMS

4.1. The Committee shall consist of eight (8) members appointed by resolution of Council.

4.1.1. Two (2) members shall be Greenview Councillors.

4.1.2. Four (4) members shall be appointed from the Local business, tourism, and workforce development community. Preference will be given to applicants who own, operate, or represent one of the following:

- A) Hotel;
- B) Motel;
- C) Vacation rental;
- D) Campground or RV park;
- E) Tour operation;
- F) Restaurant;
- G) Business association, chamber of commerce, or workforce development or community employment organization serving the area; or
- H) A resident or former resident with extensive knowledge of Grande Cache, its community, tourism assets, local economy, or workforce needs.

4.1.3. Two (2) members shall be representatives of Local Indigenous nations or organizations.

- 4.2. The Committee shall be supported by two (2) non-voting members of Administration, as assigned by the Chief Administrative Officer.
- 4.3. A quorum of the Committee shall be a simple majority of appointed members.
- 4.4. Any vacancies caused by the death, retirement or resignation of a member may be filled by resolution of Council.
- 4.5. The Committee shall appoint the Chair of the Committee by majority vote of the members of the Committee, at the first meeting. The Chair shall preside at the meetings of the Committee in accordance with Greenview's Procedural Bylaw.
- 4.6. A Vice-Chair shall be appointed by majority vote of the members of the Committee at the first meeting. The Vice-Chair shall preside at the meetings of the Committee in the absence of the Chair.
- 4.7. In the absence of the Chair and Vice-Chair, one of the other members of the Committee shall be elected by members to preside that meeting.

5. DUTIES AND AUTHORITY

- 5.1. The Committee shall:
 - 5.1.1. Identify and evaluate opportunities to attract a private developer(s) to establish an All-Season Resort in Grande Cache;
 - 5.1.2. Identify and recommend Crown land in the vicinity of Grande Cache considered suitable for designation as an All-Season Resort area under the Act;
 - 5.1.3. Advise Council on strategies, incentives, and conditions that may support the attraction of resort development to the area;
 - 5.1.4. Assess how a future resort could complement existing Local businesses, tourism operations, and community infrastructure; and
 - 5.1.5. Engage with residents, business owners, tourism operators, and Indigenous communities to ensure community perspectives are reflected in the Committee's recommendations.
- 5.2. The Committee has no authority to make decisions, enter into agreements, incur expenditures, or otherwise bind Greenview or Council. All recommendations of the Committee shall be submitted to Council for consideration and final determination.

6. MEETINGS

6.1. Meetings of the Committee will be held on a monthly basis. Additional meetings may be scheduled at the call of the Chair as matters dictate.

7. COMING INTO FORCE

7.1. This Bylaw shall come into force and effect upon the day of third and final reading.
