1.	Residential snowplowing services will be provided to eligible properties as described in Greenview Policy 4020 Snowplowing of Rural Residential Driveways (current version or replacement thereof). Greenview requires all Applicants to review this policy. I have read and understand this policy.					
2.	Driveways will be cleared ONLY as time and priorities allow and will be cleared with snowplowing equipment that is available in the area and is most efficient for Greenview's operations.					
3.	The Applicant shall receive a one-time Snowplow Request Sign indicating the Applicant's agreement number. Snowplow Signs remain the property of Greenview. Lost or stolen signs will be replaced by Greenview at the expense of the Applicant as per the current Schedules of Fees Bylaw.					

The Applicant is responsible for returning the Snowplow Sign to Greenview if they no longer require

services, they relocate or sell the property.



4. Greenview will snowplow the Applicant's driveway at the discretion of Greenview once requested by the Applicant, by way of displaying their Snowplow Sign at a location that is <u>easily visible to the Equipment Operator</u> at the driveway entrance.

It is the sole responsibility of the Applicant to ensure their Snowplow Sign is displayed appropriately for service <u>requests or refusals</u>.

Displaying the sign at the driveway entrance will be understood as the Applicant's request for snowplowing service.



- 5. Fees are established by Greenview in the current Schedules of Fees Bylaw.
- 6. Greenview shall forward invoices to the Applicant showing all charges incurred by the Applicant for snowplowing completed by Greenview and the Applicant shall pay for all charges within thirty (30) days immediately following the invoice date. If the Applicant does not pay their account, the service will be suspended until the account is paid and any balance remaining outstanding shall be a debt due to Greenview.
- 7. The Applicant agrees to hold Greenview, its servants, contractors, agents, and employees harmless against all loss, damage, or injury, however caused regarding this snowplowing service.

- 8. Greenview retains the right to refuse to clear a driveway should the Equipment Operator have any concerns about safety, equipment damage, private property damage, private driveway surface damage, the ability to exit the site, or where a gate prohibits access.
- 9. Greenview will inform the Applicant of any policy or rate changes regarding the snowplowing service by providing thirty (30) days' written notice with a request of acknowledgement from the agreement holder via digital communication or in writing. If acknowledgement is not received, the service will be suspended. The notice and acknowledgement will become part of this Agreement.
- 10. The Applicant must apply for this service annually by the last Friday of October. Any yard site changes must be reflected on the new Agreement. Applications received after this deadline may experience a 30-day processing delay prior to receiving services.
 - a. The Applicant is responsible for posting the annual renewal sticker on their issued sign in order to receive continued service.
 - b. Renewing Applicants will retain their previously issued snowplow sign.

- 11. This Agreement can be terminated by either party upon seven (7) days written notice.
- 12. This Agreement cannot be re-assigned or transferred.
