BYLAW NO. 13-697

of the Municipal District of Greenview No. 16

A Bylaw of the Municipal District of Greenview No. 16, in the Province of Alberta, for the operation of Off-Highway Vehicles on municipal roads within the corporate limits

1. This Bylaw may be cited as the "Off-Highway Vehicles" Bylaw.

Definitions

- 2. In this Bylaw:
 - (a) "**Road**" means thoroughfare, street, road, trail avenue, parkway, driveway, viaduct, lane, alley, square, bridge, causeway, trestleway or other place within the jurisdiction of the Municipal District of Greenview No. 16 which the public is ordinarily entitled or permitted to use for the passage or parking of vehicles, and includes:
 - (i) Where a ditch lies adjacent to and parallel with the roadway, the ditch, and:
 - (ii) When a highway right-of-way is contained between fences or between a fence and one side of the roadway, all the land between fences, or all the land between the fence and the edge of the roadway, as the case may be.
 - (b) "Off Highway Vehicle" means any motorized vehicle designated for cross-country travel on land, snow, or ice, and includes, when designed for such travel,
 - (i) motorcycles and related 2-wheel vehicles;
 - (ii) all terrain vehicles (which includes quads and trikes);
 - (iii) snow vehicles.
- 3. The operation and/or use of off-highway vehicles shall be permitted on roads within the corporate limits of the Municipal District of Greenview No. 16, as specified and restricted by this bylaw.
- 4. Operators of off-highway vehicles on the Municipal District of Greenview No. 16 roads shall be permitted to travel on the shoulder or, where there is no shoulder, on the extreme right-hand side of the roadway (ditch) and shall travel in a single file at all times.

- 5. This Bylaw does not apply to roadways which are not under the jurisdiction of the Municipal District of Greenview No. 16 including, but not limited to, Provincial Highways.
- 6. No person shall operate an off-highway vehicle on any road within the Municipal District of Greenview No. 16 where signs prohibit.
- 7. All pertinent legislation contained within the Traffic Safety Act and amendments and regulations thereto apply to this Bylaw.
- 8. The operation of any off-highway vehicle is prohibited at all times within any Municipal District of Greenview No. 16 park or playground, unless otherwise posted.
- 9. The provisions of Section 8 of this Bylaw shall not apply to:
 - (a) Any Peace Officer while performing his/her official duties; or
 - (b) Employees, agents or contractors of the Municipal District of Greenview No. 16 while performing their duties.
- 10. This Bylaw shall come into effect upon final passing.

Read a third time and finally passed this <u>23</u> day <u>April</u>, of <u>2013</u> AD.
