B. That an election will be held for the election of a Senate nominee for the purpose of the *Alberta Senate Election Act*;

C. That a vote of the electors will be held on the following referendum question(s) under the *Referendum Act*:

1. "Should section 36(2) of the Constitution Act, 1982 – Parliament and the government of Canada's commitment to the principle of making equalization payments – be removed from the constitution?"
2. "Do you want Alberta to adopt year-round Daylight Saving Time, which is summerhours, eliminating the need to change our clocks twice a year?"
