January 2023 Managers Report

Happy New Year Board Members,

During the month of December, the Community Resource Center Coordinators from the two offices assisted 478 inquires either in person or by telephone. The top three reasons people called or came in were for technical assistance, seniors related visits and employment.

On Monday January 9, the province of Alberta announced information on the New Alberta Affordability Payment Program. This program will provide \$600.00 to those who are eligible. This will mainly affect seniors, AISH (Assisted Income for the Severely Handicapped) recipients, and children of families whose combined income is under \$180,000.00. While some payments will be automatic, others may have to be applied for through the My Alberta Digital Identification program. Our offices will be able to assist navigating the application process, which begins on January 18th.

The Government of Alberta is helping local food banks and organizations put nutritious meals on more tables by providing \$20 million in funding over 2 years: details on who can apply can be found in the following link: https://www.alberta.ca/affordability-action-plan.aspx. The Valleyview and Grande Cache Food Bank as well as the Valleyview and DeBolt library were sent a direct link to this information through the Green View FCSS office.

The Town of Fox Creek has terminated their agreement for the Family Resource Network-Home Visitation and Caregiver Support spoke contract. The position has been vacant for months, and there have been very few people coming into the FCSS office requesting home visitation or caregiver supports. In the interim, the Green View FCSS office has been compiling a variety of resources and referrals on topics and parenting courses that families can access online and in person.

All the program summary reports, and 2022 statistics are being complied and will be shared in February's report. We do have the final numbers for the Community Volunteer Income Tax Program, and they are as follows:

In 2022, Green View FCSS assisted with 847 returns, bringing back a total of \$4,193,809.69 into the community. The total number of returns includes totals from guaranteed income supplement (GST), Canada Child Benefit (CCB), Guaranteed Income Supplement (GIS), Canada Working Benefit (CWB), Alberta Benefit, Climate Action Incentive (CAI) and regular returns. Out of the total number of people accessing this free service in 2022, 248 reside in Valleyview, 357 were from Sturgeon Lake and 242 Greenview residents.

The number of people who qualify for this service is an indication of how many people live on modest incomes. It is also an opportunity to decipher if individuals qualify for other provincial or federal programs and is a significant step in poverty reduction. Over the years we have invited staff from Sturgeon Lake Cree Nation to take the training with the hope they will service the residents directly in their community. This attempt has been hit and miss, as there is often high staff turnover and at times lack of consistency in individuals who are trained to file the taxes.

Advertising and promotion for this critical program will begin in February and tax clinics will begin in March and April.

Many of the FCSS staff compliment will engage in various components of Emergency Social Services training in January and February. This free training is conducted by the Alberta Emergency Management Association of Alberta, and courses include ESS Basics, Facility management, Registration and Reception Center Program/My Alberta Emergency Registration System, ESS Coordinator, and Donations Management.

The 2023 Program Guides are available and will be distributed to various key locations.

Green View FCSS is one of the locations where tickets to the Corey Hirsch presentation can be purchased. This presentation will be at the Memorial Hall on February 16, and tickets are \$20.00.

Due to weather and technological difficulties at the last Board meeting the discussion about food security in Valleyview has been rescheduled to the January meeting. Representatives from the Food Bank and Valleyview Library have been invited to attend at 10:30.

Updates from Grande Cache and FCSS Coordinators have been included in this report.

Assistant Manager Overview

Total of all individuals assisted in December: 301

*This number is the sum of clients assisted by each department (Community Resource Coordinator, Home Support Coordinator, Outreach Coordinator, and Youth Coordinator)

Another year is done and 2022 supplied the residents of Grande Cache and area new opportunities. The opportunities were programs /events like Older Adult Information Day and WiseGuyz. More detailed information will be provided in the February report after administration completes 2022 Program Summary reports.

The month of December was quieter for walk in traffic, the holiday season and colder weather are contributing factors to the decrease. Administration assisted 5 individuals in relation to domestic violence. This is mentioned because typically, the office will average 1 -2 inquiries a month specific to domestic violence so to see more than double in December is an occurrence of note. Administration believes increased awareness of the direct support, referrals and information Green View Family and Community Support Services provides for domestic violence has increased because of programs like WiseGuyz and events like Breakfast with the Guys. In short, more people are talking about Green View FCSS. For details on the type of referrals made please see the Adult Coordinator portion of this report.

Effective January 1, 2023, the Aboriginal Community Activity Fee Assistance Program was renamed to Community Activity Fee Funding. The program is now available to non-Indigenous as well as Indigenous residents of the Hamlet of Grande Cache, Cooperatives, and Enterprises. The program provides subsidized access to the Grande Cache Recreation Centre public swim, public skate, and fitness center. Access to these activities in a safe environment increases family connection, improved mental well-being, and reduction of isolation.

In late December Alberta Emergency Management Agency release their Emergency Social Services training calendar for the first part of 2023. In preparation for the upcoming wildfire season several staff in the Grande Cache office will be taking the training between the months of January and March. Subject matter includes registration and reception centre program, donations management, and ESS Coordinator. All staff in the Grande Cache office have completed Emergency Social Services Basics training.

Home Support client numbers have once again shifted. For the first time all year the number of clients in the Cooperatives and Enterprises has decreased by 4 clients. The clients were satisfied with services, but some have left town for a prolonged period and others have new family members residing with them these are the reasons clients requested cessation of services. The clients are aware that if their situation changes, they can request service to resume.

The Adult Coordinator provided support to 5 individuals impacted by domestic violence. Clients are provided with a safe space to share their experience and the Adult Coordinator then identifies the most relevant sources of support. Top of the list for referrals as a result of domestic violence were to mental health supports, legal supports, and Alberta Works. In the Grande Cache area there are three main organizations providing immediate support to victims of domestic violence: Transition House, Grande Cache Victims Services Unit, and Green View FCSS.

Outreach Coordinator

Medication delivery, transportation for essential needs, and reduction of isolation continue to be most of the work during the week. Currently there 9 individuals accessing services weekly. The support being provided enables clients to age in place.

The Outreach Coordinator has been assisting with WiseGuyz facilitation, details regarding the WiseGuyz program can be found in the Youth Coordinator section of this report.

Youth Coordinator

I Can Handle Anger began December 2 and will be delivered at Susa Creek school on Thursdays at 1:00pm till 2:00pm and Fridays from 1:30pm till 2:30pm. The grades that the Youth Coordinator had delivered the program to was Grades K-2. The classes at Susa Creek school are blended, so the Youth Coordinator did have to adapt content to be suitable for the age range in the class. In total the class had 8 youth that participated in the program, the Youth Coordinator was delighted to be back at Susa Creek school delivering programs and interacting with the kids there.

The Empathy program started on Tuesday November 29 and ran every Tuesday in December, 1:30pm – 2:00pm at Susa Creek school for Preschool ages, this is the first time the Empathy program was being delivered in schools by the Youth Coordinator. A total of 4 preschool aged kids attended the program with great results. The students were actively participating in discussions and answering questions. One more session remains to wrap up the program.

WiseGuyz wrapped up its first module, Healthy Relationships, on December 14 at the Grande Cache Community High School. The program will continue to run on Thursdays for the rest of the school year, 11:00 am -12:15 pm, resuming on January 12. Module two addresses sexual health and will build upon concepts covered in module 1. The youth have come a long way in sharing their own point of views. Opposing points of view are freely expressed and respectfully honored by participants.

Upon request from parents the Babysitting course was delivered prior Christmas break, December 12-15, afterschool. Two youth registered and participated. The Youth Coordinator was not disappointed by the low registration because the two youth that registered required one on one assistance with reading and comprehension of content. It was time well spent and youth are well prepared to look after their younger siblings.

• Home Support

The Home Support program provides basic housekeeping, meal preparation, limited respite, and transportation to medical appointments or other essential services. Currently, there are 74 clients, 48 from the MD and 26 in Valleyview. The program provided transportation for 11 trips during the month of December.

Balance Restorative Yoga

This program is a strength and core-building yoga, it is designed to assist in injury or post-surgery recovery. Run twice a week for maximum benefit, specifically for fall prevention. Balance is booked to start again on Jan 9^{th} in the new year. Program registration has been overcapacity, so we are going to run two sets of classes. People will have the option of registering for morning or afternoon classes.

Community Volunteer Income Tax Program (CVITP)

The CVITP program utilizes volunteers to prepare income tax and benefit returns for people with modest incomes and simple tax situations. The program runs year-round, and community members can utilize the program throughout the year to get current and past returns completed.

In 2022 the program completed 720 tax returns for low-income clients. Most of the returns, 576 were done in the months of March and April.

The Support and Referral Program supports clientele by finding appropriate programs or assisting with applications and or advocacy. The Adult Coordinator assists people with caregiver support, entry into care facilities, estate paperwork, and advanced planning tasks such as doing Wills, Power of Attorney, and Personal Directives, these tasks can take multiple phone calls and meetings. The Adult Coordinator assisted 460 people were 729 needs in 2022.

Client visits decreased in December to 308 from the previous month. In December, 26 clients visited the Community Resource Centre for support with Income Support. Clients made inquiries about their existing benefits, applied for new benefits, contacted their case workers, and received assistance to completed monthly reports.

26 clients also visited the Resource Centre for assistance with employment needs such as creating, updating, and printing resumes. Clients also received technical assistance with emailing resumes and submitting resumes online. Visits to the centre also included clients stopping in to view the job board and occasionally take copies of the employment opportunities that were posted on the job board.

Green View Family & Community Support Services 4707 – 50 Street, Box 1079 Valleyview, Alberta TOH 3N0 There were many calls and inquiries about the Food Bank in December. 24 calls or visits were regarding accessing the Food Bank, starting a new application or rescheduling a pick up due to being unavailable on the Food Bank date. Some of these calls also included residents and businesses looking to donate to the Food Bank over the Christmas season and needing contact information to do so. Clients also contacted the Community Resource Center regarding Santa's Annonymous applications and coordinators assisted them by providing applications and emailing them to the organizer.

The CRC Coordinator and Support Coordinator prepared and delivered 30 Green View FCSS Baby Book Bags to the Health Unit in December.

The Support Coordinator is scheduled to attend AEMA ESS Registration and Reception Centre Program/MyAlberta Emergency Registration System in January and the CRC Coordinator will attend in February 2023.

January Programming

Greenview Regional Multiplex

• The Empathy Program, this program provides stories, songs and activities that enhance empathetic development for children ages 3-5. This parented program will be held at the Greenview Regional Multiplex and run for 6 weeks starting January 20. FCSS will be collaborating with the Greenview Regional Multiplex to provide the Empathy Program along with a Play Program afterward, a stay-and-play physical literacy component.

Ridgevalley School

 The school has requested a Boys Group in grade 3, 4 and 5. The Boys Group program focuses on effective and respectful communication, healthy relationships and being able to express emotions effectively. This program will run for 10 sessions, Mondays and Wednesdays starting January 9.

GSA - Gay Straight Alliance

This afterschool youth led program allows 2+LGBTQ, two-spirited, lesbian, gay, bisexual, transgender, queer and questioning youth a safe place to meet and form new friendships with like-minded youth. This program runs every Wednesday from 3:30-5:30 at the Valleyview Public Library. Currently, the GSA has seven regular attendees. Youth Program Coordinator provides resources and information when required.

Outcomes 2022 – Nine youth surveyed

- 100% of youth feel safe when attending GSA.
- 89% of youth attending GSA feel it has helped them create more healthy relationships.

Relationship & Sexual Health - The grade 7, 8 and 9 will participate in this six-week program.
 Through participation, youth will develop the knowledge and skills needed to make healthy and informed decisions about their sexual and reproductive health and to participate in healthy relationships. This is taught through three core and interconnected domains: 1. Sexual and reproductive health promotion and education; 2. Healthy and respectful relationship education; and 3. Violence prevention and consent skills promotion.

<u>Other</u>

- Youth Program Coordinator will be attending virtually, Violent Threat Risk Assessment from an Indigenous Perspective Training on January 30 & 31.
- Youth Programmer will be attending the Interagency meeting on January 10th and will be presenting information on the termination of Fox Creeks FCSS Family and Resource Networks home visitation and caregiver supports. Green View Family and Community Support Services will be compiling a list of resources for family and parenting supports to help fill the gap.

- Youth Programmer has been in correspondence with the Youth Mental Health Director from the Resource Centre for Suicide Prevention and FCSS Youth Program Coordinator at Grande Cache. There have been discussions on collaborating with the Youth Mental Health Director. A follow up meeting will occur January 27.
- Youth Program Coordinator will be participating in virtual Emergency Social Services Training on January 12.
- Youth Coordinator will be attending a zoom meeting on January 13 with Grande Cache FCSS Manager and the Youth Program Coordinator to check in and discuss each community's programs.
