



# MUNICIPAL DISTRICT OF GREENVIEW

## Contract of Participation – Wolf Harvest Incentive Program Between Participants and the Municipal District of Greenview No. 16

In an effort to support population control efforts and to further public interest regarding predatory wildlife, the Municipal District of Greenview No. 16 (“Greenview”) has approved a Wolf Harvest Incentive Program (“Program”) for the purpose of promoting wolf harvesting within the Municipality. Through this program, eligible individuals (“Participants”) shall receive monetary compensation (“Compensation”) with the presentation at a location designated by Greenview Administration of an adult wolf carcass harvested lawfully within Greenview boundaries and in accordance with this Contract (“Contract”) of Participation.

The terms and conditions of participation in the Program are as follows:

1. **STATUTORY ADHERENCE:** While participating in the Program, the Participant shall, at all times, abide by all statutes, regulations, and bylaws enacted by the Federal, Provincial, and Municipal governments, and the Participant agrees there has been NO violation of any statutory or regulatory provision in any way. The relevant statutes include but are not limited to: the *Firearms Act*, the *Petty Trespass Act*, the *Wildlife Act*, and the *Wildlife Regulations* or any current *Hunting or Trapping Regulations*. A Participant who fails to strictly adhere to all relevant laws shall forfeit any right to Compensation under the Program.
2. **INDEMNIFICATION AND SAVE HARMLESS:** The Participant shall indemnify and save harmless Greenview, its officers, representatives, agents and employees, from and against any and all liability for any and all claims, costs, damages and expenses or liability arising out of or on account of injury or death to persons or damage or destruction to property resulting from or arising out of or in any way connected to the Program or participation in the Program.
3. **PRECONDITIONS OF COMPENSATION:** In order to obtain the Compensation, the carcass of a lawfully harvested wolf shall be presented to an appropriate representative of Greenview at a receiving location as designated by the representative responsible for Administration of the Program. Any carcass received by a representative of Greenview shall be marked, and any carcass that has been previously marked by a representative of Greenview shall be rejected. To qualify for the Compensation, a wolf must have been lawfully harvested within the boundaries of Greenview, by a registered landowner of property within the boundaries of Greenview, or their designate (stated through written permission). Any individual who has not previously agreed to the terms and conditions of this Contract shall be considered ineligible to receive the Compensation. The Participant shall provide the date of harvest and the location where each wolf was harvested, and shall produce appropriate documentation as follows:
  - a. **If the wolf was harvested on private property**, the Participant shall, at the time of presentation of the carcass to a representative of Greenview, produce **either**:
    - i. a dated letter of permission, signed by the registered owner or authorized occupant of the property, authorizing the Participant to harvest wolves on the property; or,
    - ii. proof that the Participant is the registered owner or authorized occupant of the property.
  - b. **If the wolf was harvested on public lands**, the Participant shall, at the time of presentation of the carcass to a representative of Greenview, **produce one** of the following:
    - i. proof that the Participant is authorized to maintain livestock on that land (i.e. Grazing Lease);
    - ii. a dated letter of permission, signed by the person authorized to maintain livestock on that land, authorizing the Participant to harvest wolves on the land; or
    - iii. proof that the land is within 8 kilometres (5 miles) of titled lands
4. **COMPENSATION:** If and only if the representative of Greenview is satisfied that the Participant has complied with the terms and conditions of this Contract, the Compensation shall be paid by Greenview to the Participant. Compensation shall be paid by Greenview to a successful Participant at the rate established in the Schedule of Fees Bylaw, which may be amended from time to time as determined by Greenview Council.
