MOTION: That the Agricultural Service Board recommend the draft Agricultural Education Grant Policy to the Policy Review Committee for consideration, as presented.

BACKGROUND/PROPOSAL:

On November 30th, 2022, the Agricultural Service Board requested that Administration draft a young or small farmer continuing education policy for presentation and consideration of the Agricultural Service Board at the February 1st, 2023, Agricultural Service Board meeting.

To meet this request Administration drafted a policy which has been called the Agricultural Education Grant. This grant will give a maximum of \$1000 to eligible applicants. These funds can be used to fund any costs associated with attending educational events with an emphasis on agriculture. Applicants must demonstrate financial need, an invested interest in agriculture, and be starting, trying to start, or grow their agricultural operation.

This draft policy was presented at the Agricultural Service Board meeting on February 1st, 2023. A motion was made at that meeting for the policy to be brought back to the Agricultural Services Board as amended.

The amended policy has been attached for the Agricultural Service Board's consideration.

BENEFITS OF THE RECOMMENDED ACTION:

The benefit of the recommended action is that agricultural producers will be encouraged to attend educational events in agriculture without the financial risk. This also builds a relationship between Greenview and allows administration to find avenues to support agricultural producers with emphasis on young or new producers who may benefit from direction in the industry.

DISADVANTAGES OF THE RECOMMENDED ACTION:

The disadvantage of this recommended action is that some applicants may be denied due to budget constraints if the budgetary maximum has been met for that year. This can create some ill feelings from those who have not been accepted. There is also the potential that some producers may feel that Greenview is not supporting older, more experienced producers in the same way as the younger or more inexperienced producers.

ALTERNATIVES CONSIDERED:

The Agricultural Services Board has the option to deny, alter, or accept the recommended action.

FINANCIAL IMPLICATION:

Direct Costs: Administration recommends a budgetary maximum of \$4000/year.

Policy 8008 "Postsecondary Scholarships"

Purpose: To provide financial assistance to those attending agricultural education events. The Agricultural Education Grant seeks to support endeavors which expands knowledge of the agriculture industry.

1. DEFINITIONS

- 1.1 **Chief Administrative Officer (CAO)** means the Chief Administrative Officer of Greenview, or designate.
- 1.2 **Eligible Applicant** means an applicant who meets the grant criteria established in the general principles for selection
- 1.3 **Greenview** means the Municipal District of Greenview No. 16.
- 1.4 **Primary Residence** means living in a house, rental, or in the case of an entry level producer, in shared accommodations within the boundaries of Greenview.

2. POLICY STATEMENT

- 2.1. The Greenview Agricultural Service Board will annually dedicate up to \$1000.00 to each applicant until the budgetary maximum of \$4000.00 has been reached each year.
- 2.2. Applicants attending any educational event with an emphasis on agriculture are eligible for a \$1000 grant. Educational event includes:
 - A) Conferences;
 - B) Presentations;
 - C) Classes;
 - D) Speakers; or
 - E) Any other event deemed acceptable
- 2.3. Grants will be awarded to Eligible Applicants whose Primary Residence is in Greenview and will be attending an educational event with an emphasis on agriculture.
- 2.4. The CAO may award a maximum of \$1000.00 to an applicant for Agricultural Education Grant.

- 2.5. Applicants who are applying for this grant to be contributed towards full time postsecondary studies will not be considered.
- 2.6. If attending an event that is primarily livestock based, the event must be focused on cattle, swine, sheep, goats, bees, cutter bees, bison, or poultry production to be eligible for an Agricultural Education Grant.

3. AGRICULUTRAL EDUCATION GRANT

- 3.1. Successful applicants may utilize the Agricultural Education Grant to cover the following expenses while attending an agricultural education event:
 - A) All costs associated with travel including accommodations and subsistence;
 - B) Registration or course fees; and
 - C) Cost of acquiring daycare or animal care.
- 3.2. Selection principles of the Agricultural Education Grant:
- A) Applicant's Primary Residence is in Greenview;
 - B) The applicant demonstrates financial need;
 - C) The applicant is under 40 years of age;
 - D) The applicant currently owns, works on, or demonstrates a strong interest in an agricultural operation;
 - E) Preference will be given to applicants who are new to the agriculture industry and/or are trying to start, have recently started, or are trying to grow, their agricultural operation;
 - F) Preference will be given to applicants who have not been previously awarded a grant from Greenview.
- 3.3. Applicants may apply or re-apply for a grant each year that they are attending an agricultural educational event provided they meet the selection criteria.

4. PROCEDURE

- 4.1. Application forms will be available at any Greenview Public Service Building or on the Greenview website. Applications will remain open until the budgetary maximum has been met.
- 4.2. Only completed applications will be considered.
- 4.3. Successful applicants will be notified by Greenview Administration.
- 4.4. The successful applicant, following the receipt of an acceptance letter from Greenview, must provide proof of enrollment or attendance at the event to Greenview Administration before grant funds will be released.

5. COUNCIL RESPONSIBILITIES

5.1. Council shall annually review and approve the Agricultural Education Grant budget.

6. ADMINISTRATION RESPONSIBILITIES

- 6.1. Administration shall annually prepare the Greenview Grant Portal to accept applications for the Agricultural Education Grant.
- 6.2. Administration will inform Council of all payments made under this policy.

1) Describe the event and what you will be gaining from it.

The event I attended was the Alberta Beef Industry Conference at The Fairmont Banff Springs Hotel. This event is Alberta's main conference for all information relating to the beef industry. From this event I was able to attend a variety of speaker sessions where I learned a lot about the economics of the beef industry, climate change impacts, and global market trends. At this event I was also able to connect and network with many other producers which will benefit my farm as I now have a network to reach out to for more opportunities when it comes to buying or selling livestock, feed, etc.

2) Explain your eligibility for this grant (i.e., why should Greenview choose you to receive this grant).

I think I am eligible for this grant because I live in Greenview and am a young agricultural producer. I have worked an off-farm job at NoName Industries for the last 10 years. 4 years ago, I bought a house with a quarter section of land. On that quarter section I have 20 chickens, 35 cows, 4 pigs, and 10 sheep. I am currently saving up to purchase another quarter section where I plan to expand my operation and buy more cattle. I am currently a member of the Valleyview Grazing Reserve where I have an allotment for 20 heifers. Starting out in the agriculture industry has presented many financial challenges and while I would like to attend more educational events to aid in my learning of the industry, due to financial constraints this is not always possible. Receiving this grant would ease some of the financial impact from attending this event.

3) Outline the approximate costs associated with attending this event.

The cost of the hotel was \$200/night and I stayed for 2 nights. Registration for the event was \$650. The travel cost to drive to Banff and back from the Valleyview area was \$200. For the 2 days I was gone my two children went to daycare which was \$150/day for two days for a total of \$300. My neighbor fed my livestock for me which cost \$200/day so \$400 total.

Adding up all those costs (not including the lost wages from taking days off) was \$1950 worth of expenses.

Administrative note: based on this application John would likely be accepted for the grant, providing the budgetary maximum had not been met for that year. Due to the high cost of this event John would receive the maximum amount of \$1000. He will receive an acceptance letter from Greenview administration. Upon receiving this acceptance letter, he will be required to provide proof of attendance. This would include his invoice from registering for the conference, hotel receipt, daycare receipt, and any other supporting documents.

Example# 2: Grain producer applying proactively for a course.

1) Describe the event and what you will be gaining from it.

The course I plan on enrolling in is the Integrated Crop Management Course offered through Lakeland College. This course is an 11-week self-paced study that takes 40-60 hours to complete. The description of this course is pulled from the Lakeland website "This course is an overview of Integrated Crop Management (ICM). The emphasis is on the importance of integration across all of the disciplines critical for crop production. Soil and plant science, while not the foundation of this course, will be included where necessary in the course work." I think this course will help me implement better management practices on my farm.

2) Explain your eligibility for this grant (i.e., why should Greenview choose you to receive this grant).

I am a young producer (26 years old) and currently own two quarter sections of land that I inherited from my grandparents. I graduated from X College with a diploma in Animal Health Technology. I have been working as an AHT for X Veterinary Services for the past 5 years. I don't have any formal education in crops and would like to take this course to expand my knowledge so I can better understand how to best manage my land. While I am not a member of any community or agriculture groups, I do stay up to date on agricultural news from various media sources.

3) Outline the approximate costs associated with attending this event.

The registration cost for this course is \$780. There are no other costs associated with this course.

Administrative note: based on this application Jane would likely be accepted for the grant, providing the budgetary maximum had not been met for that year. Jane would likely receive the exact course amount of \$780. She will receive an acceptance letter from Greenview administration. Upon receiving this acceptance letter, she will be required to provide proof of enrollment. This would be the receipt from Lakeland College when she pays her enrollment fee.

In alignment with the 2022-2025 Greenview Strategic Plan, some of the key activities and projects worked on by Agricultural Services in April were:

Governance

Greenview Agricultural Services sent one problem wildlife officer to Ottawa in their capacity as a Director for the Fur Institute of Canada for the Insistutes lobbying efforts. Expenses for the trip were covered by the Fur Institute of Canada for what they call "Fur Day on the Hill" and the officer attended 28 meetings in total with Members of Parliament and Senators. Contact was made with Alberta-elected Members of Parliament that were interested in what Greenview is doing regarding wild boar. Information was shared regarding Greenview's concern regarding wild boar, that the municipality is actively pursuing eDNA detection, and is working with the province and neighbouring municipalities as Greenview is on the leading edge of the range of the invasive species. The Alberta-elected Members of Parliament indicated they would be interested in learning more about Greenviews efforts in the future. Additional topics of conversation revolved around the need to keep coyote numbers in check, the downturn in fur prices, and indigenous issues.

Administration met with Alberta Forestry and Tourism to discuss weed concerns in the Willmore Wilderness Area. Utilizing Greenview's partnership with the Alberta Invasive Species Council, Administration will offer training to the Willmore Wilderness Association and recreation enthusiasts on weed identification and mapping through the citizen science detection application, EDDMaps. Administration learned that to facilitate Greenview weed inspections within the Willmore, a temporary field authorization will be required. Agricultural Services will have the authorization filed in time to conduct formal inspections in 2023. Talks have begun with Yellowhead County for a joint effort to cover the entire Willmore Wilderness Area in this inspection effort to facilitate the creation of a three-year weed management plan, bolstered by an education and awareness campaign. The first education event is hoped to take place the first week of June. Administration will keep Council informed as to new developments.

Weed inspections have begun with preliminary phone calls to landowners with scentless chamomile and tall buttercup infestations taking place. These phone calls are meant to touch base and extend offers of assistance through Greenviews various weed control programs and serve as a point of contact prior to agricultural producers being in the fields. Landowners with an active clubroot notice were called to remind them of Greenview's inspection procedures and which fields to not plant canola in. These are informal courtesy calls

done to reduce unintended canola planting in a field, reducing the likelihood of the department needing to enforce on a notice.

Economy

The Landcare Coordinator delivered a Classroom Agriculture Program presentation to grade 4 students at St. Stephens in Valleyview. The presentations went very well, the students asked many questions and seemed very interested. The shelterbelt program is nearing a complete sell out and an extension event to assist ratepayers in successful planting and maintenance of trees will happen on May 11th. In support of these efforts and in cooperation with the Greenview Communications department, Agricultural Services is happy to report the publication of "Greenview Tree Resources", written by the certified arborist who will also be delivering the planting event.

The intention of this is to control potential issues prior to flooding or damaging of the underlayment of Greenview infrastructure.

The recently released 2023 provincial budget has shown a 60% increase in crop insurance premiums from the 2022 provincial budget and an average of 22% increase over 2022 actual crop insurance premiums. The Brazeau County Agricultural Service Board (ASB), would like to express their concern of this proposed increase, as this additional cost will have a negative financial impact on small to mid-sized operations within our County and the Province.

Local producers and producers across this province are facing unprecedented challenges. Increasing input costs, increasing operational expenses, changing and challenging weather conditions and extreme weather events, disease outbreaks etc. Because of these challenges, farmers are experiencing higher rates of stress, anxiety and depression. RE: Letter of support concerning PMRA's change to insecticide lambda-cyhalothrin

Dear Minister Horner, Minister Bibeau and Minister Duclos,

Cypress County's Agricultural Service Board (ASB) is in support of Minister Nate Horner's letter to Ministers Marie-Claude Bibeau and Jean-Yves Duclos regarding the Pest Management Regulatory Agency (PMRA) decision to change the use of the insecticide lambda-cyhalothrin that was effective April 1, 2023.

This has been a very effective insecticide for grasshopper and flea beetle control in crops for farmers and ranchers in Cypress County and we are extremely concerned about the PMRA's decision to change the use of lambda-cyhalothrin.

Since the insecticide can no longer be applied to any crop that may be used for livestock feed, the manufacturer/distributer of Matador has pulled their products containing the active ingredient lambdacyhalothrin from Western Canada.

Southern Alberta has experienced two extremely dry years and 2023 is expected to be a bad year for grasshoppers in Cypress County making this terrible timing for controlling these destructive insects.

In the interest of Cypress County and Alberta producers, we urge you to intervene and encourage the PMRA to reconsider their decision to implement changes for use of lambda-cyhalothrin on product labels, effective April 1, 2023, until another effective alternative product is in place and to reverse their decision regarding this important product.

The 2023 season is quickly approaching, and producers would greatly appreciate quick action of this matter.
