Contract for Participation:

1. Landholders are eligible for a rebate (\$/acre) for controlling any of the following;
 - Tall Buttercup (*Ranunculus acris*),
 - Burdock (*Articum lappa/minus/tomentosum*),
 - Common Tansy (*Tanacetum vulgare*),
 - Scentless Chamomile (*Tripleurospermum inodorum*),
 - Ox-Eye Daisy (*Leucanthemum vulgare*),
 - White Cockle (*Silene latifolia Poir. ssp. alba*),
 - Common Toadflax (*Linaria vulgaris*).
2. The Weed Incentive Program is for pastures, hay lands, grazing leases, and grazing reserves,
3. Industrial, commercial, hamlets, and summer villages are not eligible for the rebate,
4. The rebate is \$15.00/acre sprayed,
5. Landholder eligibility is based upon the application of residual herbicide (as outlined below) according to the manufacturers' label and manufacturers' recommendations,
6. The rebate payment will be calculated using the number of acres sprayed with approved herbicide (confirmed by a copy of the purchase invoice) provided by the landholder, multiplied by the \$/acre rebate. Department staff will confirm that the herbicide was applied and the desired level of weed destruction or control was achieved,
7. The rebate incentive is to a maximum of \$2,400.00 per landholder per year,
 - a. Recommend chemical control completed by June 30
 - b. Participant informs Agricultural Services once the work has been completed to facilitate post-control inspection. **POST INSPECTIONS ARE REQUIRED.**
 - c. All forms filled out and submitted to the Greenview Agricultural Services Department by September 15, include a copy of purchase receipts
 - d. Rebate will be calculated on acres covered by chemical purchased
8. The following is an approved list of registered residual herbicides;

9. The Greenview rental sprayers will be available to the participants of the Weed Incentive Program at no charge for the purpose of this program.

I, the landholder, understand that the herbicides listed within the terms may selectively target broadleaf plants other than the species listed within this agreement and may have a residual effect for a period of time.

I, the landholder, hereby declare that I understand the effects and I agree to save harmless and indemnify the Municipal District of Greenview No. 16, its employees, and agents, from and against all actions, suits, claims, and demands arising in any manner whatsoever from activities associated with said herbicide application and/or control work.
