Fencing Items

- 1. All wire must be removed from wooden fencing material and rolled up neatly
- 2. Dispose of these items under direction of the Site Attendant

Tires

- 1. Disposal of tires in Tire recycling area
- 2. Rims can stay on, removal not needed



Burn Barrel Ashes

- 1. ONLY cold ash is accepted at all sites
- 2. Ashes must be cold to the touch
- 3. No garbage is permitted to be mixed in with the ashes
- 4. Ashes go only in the bin
- 5. Bagged ashes are preferred
- 6. Commercial or Industrial ash is not accepted at the MD Transfer Stations

Wood Material

- 1. Clean wood is disposed of at the designated Clean Wood Area. Clean wood is defined as wood that has not been treated with chemical preservatives
- 2. Treated wood is disposed of at the designated Treated Wood Area

Household Hazardous Waste

Household hazardous waste is the discarded, unused, or leftover portion of houshold products containing toxic chemicals. These wastes cannot be disposed of in regular household garbage.

Any product which is labeled WARNING, CAUTION, POISONOUS, TOXIC, FLAMMA-BLE, CORROSIVE, REACTIVE or EXPLOSIVE should be considered hazardous.

Preparing for the trip to the Transfer Station

Refer to the MD Landfill and Transfer Station Hours of Operation Information Sheet for a list of acceptable wastes for each specific site. This information sheet is available on the MD of Greenview's website (see above QR code), administration offices in Valleyview/ Grovedale/Grande Cache and at each Transfer Station.

Always check in with the Site Attendant upon arriving at the Transfer Station and dispose of your garbage only as directed by the MD Staff. Your co-operation in the correct disposal of waste material by the following instruction from the Transfer Station Attendant and the posted signage is greatly appreciated.

The following tips will help make your trip to the site as quick and easy as possible:

- 1. Tarp and secure your load to help control litter and prevent accidents
- 2. All household garbage must be bagged and tied prior to disposal
- Organize the materials in your load prior to arriving at the station. Separating the metals, woods and tires from your household garbage will make off-loading less time consuming as recyclables are already separated prior to entering the site
- Dispose of items at the Transfer Station under the direction of the Site Attendant and posted signage

Preparing items for Disposal

Although disposing of many items that are accepted at the Transfer Station is self explanatory, some items need to be prepared in a specific way prior to arriving at a site before they are able to be accepted. The following list are several common items accepted at the stations but do have an acceptance criteria that must be met.

<u>Automobiles</u>

- 1. All fluids must be drained
- 2. Tires removed
- 3. Free of garbage
- 4. No Campers/RV units or large machinery will be accepted

Structures/Buildings

- 1. Remove any plastic and insulation from the wood of the structure
- 2. Remove any tin from the structure
- 3. Remove any drywall from the walls ceilings of the structure
- 4. Remove any shingles from the structure

Freon Units (Fridges/Freezers/ Water coolers/Air Conditioners)

- 1. Remove any shelving and glass material
- 2. Ensure that the fridges and freezers are free of all food items

Barrels

- 1. Rinsed and free of all liquids
- 2. Bung caps removed or side barrel punctured

Florescent Tubes

- 1. Tubes and ballast are to be removed from the metal fixture
- 2. Metal fixture is disposed of in the metal pile
- 3. Tubes and ballasts are disposed under the direction of the Site Attendant

Pressurized Tanks

- 1. All sizes of propane tanks, including the small green ones
- 2. Helium tanks
- 3. Fire extinguishers
- 4. Tanks must be empty
- 5. The MD Transfer Stations do not accept commercial pressurized tanks
