WHEREAS, the Organization desires to provide clean-up services to transfer stations and landfills within The Municipal District of Greenview No. 16.

AND WHEREAS, The Municipal District of Greenview is willing to pay for clean-up services provided.

THE ORGANIZATION AND MUNICIPALITY AGREE:

- 1. The Organization represents and warrants that it is a Non-Profit organization.
- 2. The Organization shall provide cleaning services by picking up garbage at the transfer station or landfill as assigned by a Greenview representative and as listed under section 9 of this agreement.
- 3. Subject to the terms of this agreement, Greenview shall reimburse the Organization for its services at the rate of fifteen hundred dollars (\$1500) per site to the organization.
- 4. The Organization shall abide by the program rules as established by Greenview and be fully responsible for the activities of its workers. Failure to comply with the program rules shall result in the immediate termination of this agreement.
- 5. Greenview will supply garbage bags, gloves, and safety vests for the organizations at the site. The organization will assist the Greenview representative in picking up and disposing of bags and put in the proper bin upon completion.

- 6. The Organization shall ensure that prior to taking part in clean-up day activities, its participating members have completed the required safety orientation.
- 7. The Organization shall provide transportation, supervision and medical first aid services for its participating members.
- 8. The Organization shall indemnify and hold harmless Greenview, its employees, and agents from any and all damages, demands, claims and expenses (including legal expenses on a solicitor and own client basis) whatsoever that may arise directly or indirectly out of any acts or omissions of the Organization under this Agreement. This provision shall survive the termination of this Agreement.
