



## BYLAW 24-971 of the Municipal District of Greenview No. 16

**A Bylaw of the Municipal District of Greenview No. 16, in the Province of Alberta to amend the Non-Residential Alberta School Foundation Fund/Opted-Out School Boards within Bylaw 24-961 “Tax Bylaw 2024”.**

**Whereas**, pursuant to the *Municipal Government Act*, RSA 2000, c.M-26 and amendments thereto, the municipality may correct an error, omission or misdescription for the current year.

**Whereas**, pursuant to section 191 of the *Municipal Government Act*, RSA 2000, c.M-26 and amendments thereto, Council may amend a bylaw.

**Whereas**, the Council deems it desirable to amend the Tax Bylaw 2024.

**Therefore**, the Council of the Municipal District of Greenview No. 16, duly assembled, hereby enacts as follows:

1. **TITLE**

1.1. This Bylaw may be cited as “Tax Bylaw 2024 Amendment”.

2. **DEFINITIONS**

2.1. **ASFF** means Alberta School Foundation Fund.

2.2. **Greenview** means the Municipal District of Greenview No. 16.

3. **AMENDMENTS**

3.1. Bylaw 24-961, Tax Bylaw 2024, is amended so that references to the assessed value of all property within Greenview and Section 2.1 Non-Residential ASFF/Opted-Out School Boards will be replaced to read as follows:
