



**BYLAW NO. 07-553  
of the Municipal District of Greenview No. 16**

**A Bylaw of the Municipal District of Greenview No. 16, in the Province of  
Alberta, to establish the Hamlet of Ridgevalley.**

WHEREAS, Section 59 of the Municipal Government Act being Chapter M-26, 2006 empowers Council to declare any given area to be a hamlet and to designate its boundaries; and

WHEREAS, because development is taking place within the Ridgevalley area, it is desirable to expand and designate the boundaries;

NOW THEREFORE the Council of the Municipal District of Greenview in the Province of Alberta, duly assembled, hereby enacts as follows:

1. That the lands contained within the area outlined in red on the attached Schedule "A" shall be declared as the Hamlet of Ridgevalley in the Municipal District of Greenview.
2. That the boundaries of the Hamlet of Ridgevalley shall be established as:

All that portion of land located within the Southeast quarter of Section Twenty-two (22), within Township Seventy-one (71), Range Twenty-six (26), West of the Fifth Meridian (W5M) and the Southwest quarter of Section Twenty-three (23), within Township Seventy-one (71), Range Twenty-six (26), West of the Fifth Meridian (W5M);

**EXCEPTING THEREOUT:**

Part of Section Twenty-two (22), within Township Seventy-one (71), Range Twenty-six (26), West of the Fifth Meridian (W5M), containing 102.2 acres and Lot C, of Plan 942-1937 containing 11.0 acres and Lot B of Plan 942-1937 containing 4.0 acres and;

Part of Section Twenty-three (23), within Township Seventy-one (71), Range Twenty-six (26), West of the Fifth Meridian (W5M), containing 126.60 acres and Part of Section Twenty-three (23), within Township Seventy-one (71), Range Twenty-six (26), West of the Fifth Meridian (W5M), containing 2.60 acres and Lot 1, Plan 012-0918 containing 7.0 acres, as identified in black on Schedule "A" attached.

That Bylaw 94-15 is hereby repealed.

This Bylaw shall come into force and effect upon the day of final passing.

Read a first time this 14<sup>th</sup> day of November, A.D., 2007.

Read a second time this 12<sup>th</sup> day of December, A.D., 2007.

Read a third time and finally passed this 12<sup>th</sup> day of December, A.D., 2007.
