

BYLAW No. 25-995 of the Municipal District of Greenview No. 16

A Bylaw of the Municipal District of Greenview No. 16, in the Province of Alberta, to amend Bylaw 23-941 Greenview Cemeteries.

Whereas, pursuant to section 191 of the Municipal Government Act, RSA 2000, c.M-26 and amendments thereto, Council may amend a bylaw.

Whereas, Council wishes to amend Bylaw 23-941 Greenview Cemeteries Bylaw.

NOW THEREFORE, the Council of the Municipal District of Greenview No.16, duly assembled, hereby enacts as follows:

1. TITLE

1.1. This bylaw shall be cited as the "Greenview Cemeteries Amendment Bylaw".

2. **DEFINITIONS**

2.1. **Greenview** means the Municipal District of Greenview No.16.

3. **AMENDMENTS**

- 3.1. Bylaw 23-941 is amended by this bylaw.
- 3.2. Bylaw 23-941, is amended with the addition of sub- section vi. within section 2.1. in part D) titled "Cemetery":
 - D) **Cemetery** means land that is set apart or used as a place for the burial of dead human bodies or other human remains, or in which dead human bodies or other human remains are buried and is owned by the Municipal District of Greenview No 16. For the purposes of this bylaw, Cemetery is inclusive of the following:
 - i. Grovedale Cemetery, located at Plan 9123443, Lot 1 within SW-33-69-6-W6;
 - ii. Little Smoky Cemetery, located at Plan 5181 TR within SW-32-66-21-W5;
 - iii. New Fish Creek Cemetery, located at Plan 2521230, Block 1, Lot 1 within NE-2-73-22-W5;
 - iv. Sunset House Cemetery, located at Plan 7520564, Lot 1 within NE-1-71-20-W5;
 - v. Grande Cache Cemetery, located at Plan 69TR 37 within NE-4-57-8-W6, and
 - vi. Sturgeon Heights Cemetery, located at Plan 2220547, Block 1, Lot 1 within SE-25-70-25-W5.
- 3.3. Bylaw 23-941, is amended with the addition of sub- section v. within section 2.1. in part F) titled "Cemetery Committee":

- F) **Cemetery Committee** means a Council Committee established by bylaw of Greenview and whose members are appointed by resolution of Council. For the purposes of this bylaw, Cemetery Committee is inclusive of the following:
- i. Grovedale Cemetery Committee;
- ii. Little Smoky Cemetery Committee;
- iii. New Fish Creek Cemetery Committee;
- iv. Sunset House Cemetery Committee; and,
- v. Sturgeon Heights Cemetery Committee.

4. COMING INTO FORCE

4.1. This Bylaw shall come into force and effect upon the day of final passing and signing.
