An affected party may **APPEAL** a decision to the Subdivision and Development Appeal Board in accordance with the *Municipal Government Act, 2000, M-26, s. 685* and the provisions of the Greenview Land Use Bylaw 25-1000 or Alberta's Land and Property Rights Tribunal dependent on jurisdiction of the Appeal authority. An appeal under the jurisdiction of The Municipal District of Greenview No. 16 shall be submitted on the appropriate form and mailed or delivered to the **Subdivision and Development Appeal Board Clerk** at the address above prior to the close of business on the effective date indicated above. To be considered complete, a notice of appeal shall be signed and contain a written statement of the grounds of appeal and applicable \$500 fee.
